Project objective	The primary objective of the Project is to develop a wind energy facility that will generate and supply renewable energy into the National Electricity Market (NEM) to supplement Victoria's energy needs. The Project will support Victoria and Australia's transition to renewable energy, as well as being a key contributor to mitigating the projected impacts of climate change by providing a renewable source of energy and subsequently reducing greenhouse gas emissions from fossil fuel energy generation. It is estimated that the Project will provide clean energy for 260,000 Victorian households and avoid 350,000 tonnes of CO2 emissions annually. Additionally, the proposed wind farm will offer the following benefits: • Support the Victorian Government's legislated renewable energy target of 40 percent by 2025 and 50 percent by 2030, and the recently updated targets of 65 percent by 2030 and 95 percent by 2035 that are intended to be legislated and working to achieve net zero emissions by 2045. • Support the Commonwealth Government's commitment to achieve up to 43 percent emission reductions below 2005 levels by 2030 and net zero emissions by 2050. • Support Victoria's clean energy transition and contribute to the growth of the renewable energy industry in the Central Highlands region. • Contribute to the decarbonisation of Australia's energy market. • Invest significant funding into the regional economy, and into the Victorian economy and generate more than 200 jobs during construction. The Project will also generate indirect supply chain jobs, and employ an operations team of 10 to 15 fulltime equivalents for the life of the Project (25-30 years). • Establish a community benefit funds, participation agreements, neighbour benefit schemes, community sponsorships, and grant initiatives on construction commencing.

Project description	The Project involves a renewable energy facility comprising a wind farm, a battery energy storage facility and a transmission line to connect the Project to the electricity network, and includes (but is not limited to): • Up to 62 wind turbines, each with a generation capacity of 6.8 MW and a maximum overall tip height of 252m. • Hardstands at the base of each turbine. • Underground and overhead reticulation cabling between turbines. • Onsite electrical substation. • A 220 kV underground transmission line connecting the Project from the onsite substation into the electricity network at Berrybank Terminal Station. • Battery Energy Storge System (BESS) with a storage capacity of up to 150 MW and associated water storage tanks. • 45,000 litre water tanks at each site entrance. • Internal site access tracks. • Up to four permanent meteorological monitoring masts. • Operations and maintenance facilities. • Other permanent ancillary works, including road upgrades. The Project also requires temporary infrastructure including two construction compounds, temporary laydown areas and two concrete batching plants
